CONDITIONS

1. Ta odobritev je omejena na tisto, navedeno v oddelku o obsega odobritve odobrenega priročnika vodenja stalne plovnosti iz poddela G oddelka A Priloge I (Del M) k Uredbi (EU) št. 1321/2014.
This approval is limited to that specified in the scope of approval section of the approved continuing airworthiness management exposition as referred to in Section A, Subpart G of Annex I (Part-M) of Regulation (EU) No 1321/2014.
2. Ta odobritev zahteva skladnost s postopki v odobrenem priročniku vodenja stalne plovnosti iz Priloge I (Del M) in po potrebi Priloge Va (Del T) k Uredbi (EU) št. 1321/2014.
This approval requires compliance with the approved continuing airworthiness management exposition procedures specified in Annex I (Part-M), and if applicable, Annex Va (Part-T) to Regulation (EU) No 1321/2014.
3. Ta odobritev je veljavna, dokler je odobrena organizacija za vodenje stalne plovnosti skladna s Prilogo I (Del-M) in po potrebi Prilogo Va (Del T) k uredbi (EU) št. 1321/2014.
This approval is valid whilst the approved continuing airworthiness management organisation remains in compliance with Annex I (Part-M) to Regulation (EC) No 1321/2014.

This approval does not constitute an authorisation to operate the types of aircraft referred in paragraph 1. The authorisation to operate the aircraft is the AOC.
6. Odpoved, začasna ukinitve ali preklic AOC samodejno razveljavi to odobritev v zvezi z registracijami zrakoplova, opredeljenimi v AOC, razen če pristojni organ izrecno ne navede drugače.
Termination, suspension or revocation of the AOC automatically invalidates the present approval in relation to the aircraft registrations specified in the AOC, unless otherwise explicitly stated by the competent authority.
7. Če so zgoraj navedeni pogoji izpolnjeni, ta odobritev velja za nedoločen čas, razen če je bila predhodno umaknjena, nadomeščena, začasno ukinjena ali preklicana.
Subject to compliance with the previous conditions, this approval shall remain valid for an unlimited duration unless the approval has previously been surrendered, superseded, suspended or revoked.
